1. What can I donate?

We are able to accept most cars, trucks, RV's, trailers, boats, and some jet-skii's, snowmobiles and motorcycles as well!

2. My car hasn't run in years. Can I still donate it?

Yes, we are able to accept most vehicles running or not (exceptions include vehicles whose value would not offset the cost of towing). To find out if we can

7. Is my donation tax deductible?

Yes, vehicle and vessel donations made to bona fide charitable organizations are tax deductible to the full extent of the law. We have verified that all charities listed within this site are classified with the IRS as non-profit charitable organizations. However, individual tax situations vary so please check with a tax professional to determine what if any tax benefit you may receive from a tax deductible donation.

8. How does my tax deduction work?

The IRS allows you, the taxpayer, to claim a tax deduction of (a) the value of your vehicle up to \$500 or (b) if we sell the vehicle for more than \$500 we will mail you a completed IRS tax form 1098-C with that value for your tax purposes.

For additional information, the IRS provides a Donor's Guide to Car Donations which sets forth the manner in which the IRS requires you to determine the value of your donated property.
